INVESTMENTS BY FUND BY TYPE AT June 30, 2014

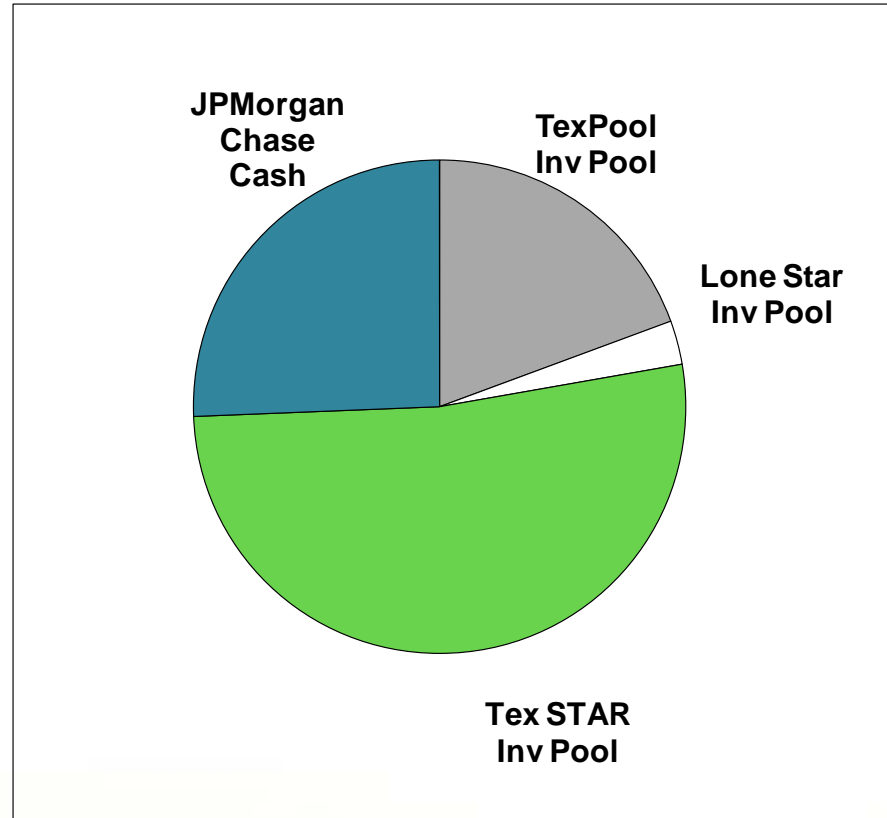

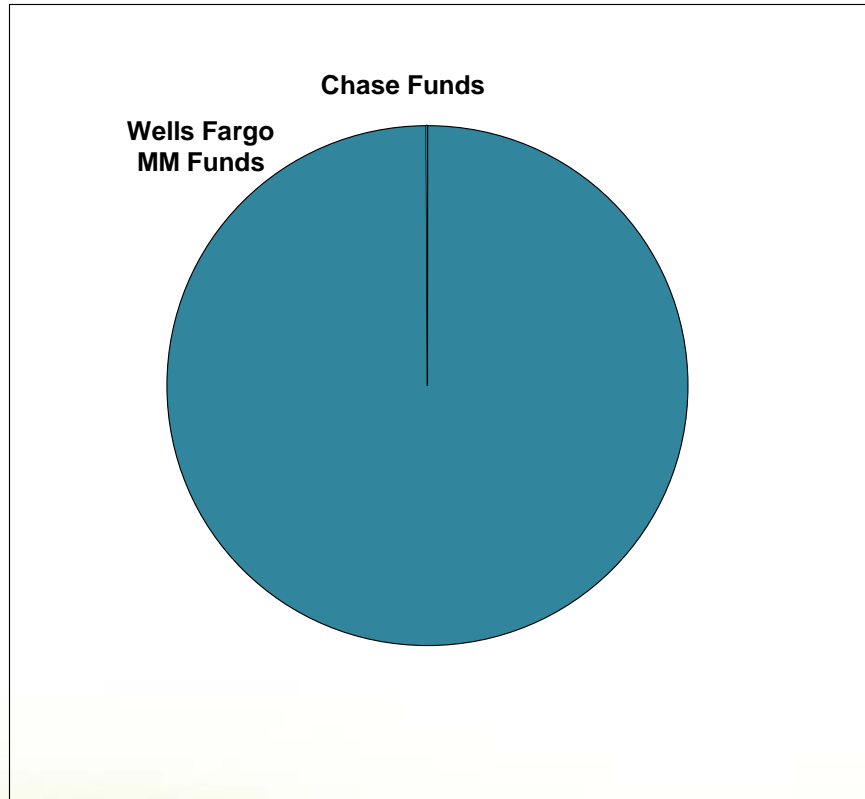

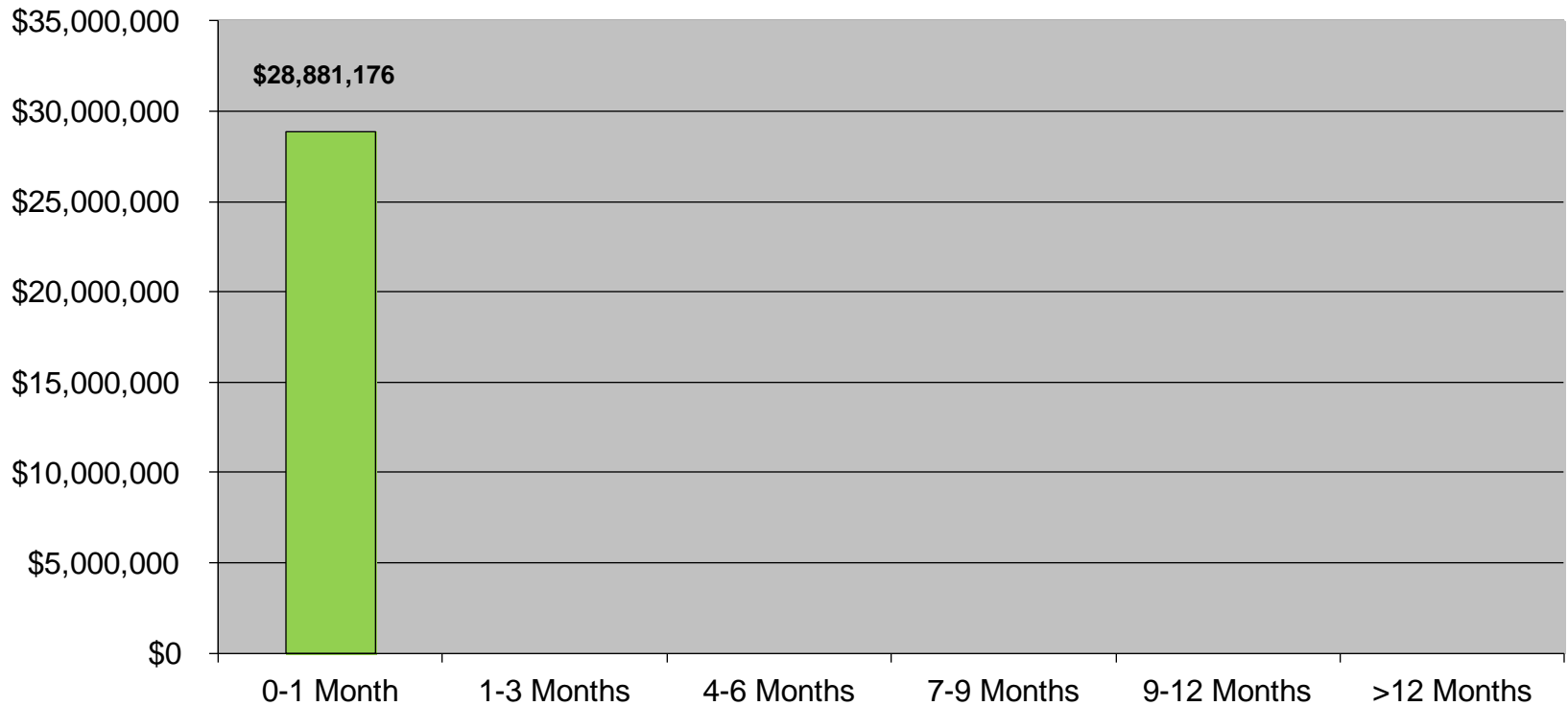
